

# **TERMS OF USE**

Thank you for choosing Biqutex (the 'Website'), which is a platform dedicated to the transaction of cryptocurrency exchanging and the provision of related services (the "Services"). The website and trading platform owned and operated by Biqutex Limited, the Website and the Company are referred to "we," "us" or "our". or other applicable forms of first person pronouns in this Agreement. All individuals who create a Biqutex account are referred to "You" or "Your". You should read, agree and comply with the terms and conditions of use stated bellow ("Terms of Use") carefully.

#### **Modification of Terms**

We may, at Our sole discretion, change, modify, add, or remove portions of these Terms and to the Services from time to time without any prior written notice to You. We may do this for a variety of reasons including to reflect changes and requirements under the law, new features, or changes in business practices. It is Your responsibility to review these Terms periodically for updates/changes. Your continued use of the Services following the posting of changes will mean that You accept and agree to the revisions.

# **General Requirements**

The Services are intended solely for Users who are 18 (Eighteen) years and above (or at least the age to enter into legally binding contracts in your jurisdiction, when higher) and who satisfy the criteria described in these Terms. You represent and warrant that You: (a) are of legal age to form a binding contract; (b) have not previously been suspended or removed from using our Services; (c) have full power and authority to agree to these Terms; and (d) are not prohibited in the jurisdiction applicable to You from undertaking activities on respect of the Services.

#### **Restricted Locations**

You shall not use the Services if You are located in, or a citizen or resident of the United States of America (including all United States territories such as Puerto Rico, American Samoa, Guam), Hong Kong, Cuba, Crimea and Sevastopol, Luhansk People's Republic, Donetsk People's Republic, Iran, Sudan, Afghanistan, Syria, North Korea and any other state, country, territory or other jurisdiction as decided by Us from time to time or where Your use of the Services would be illegal or otherwise violate any applicable law. You represent and warrant that You are not a citizen or resident of any such jurisdiction and that You will not use any Services while located in any such jurisdiction. If we determine that you are accessing the Services from any Restricted Jurisdiction, or have given false representations as to your location of incorporation, establishment, citizenship or place of residence, we reserve the right to close any of your accounts immediately and liquidate any open positions.



# "EARLY BIRDS" BONUS PROGRAM TERMS AND CONDITIONS

#### 1. Moderation

- 1.1.
